Doing all of these at once would come with a hefty price tag and would need public approval.

  - Jim suggests pushing the improvements to FY26 and also stated there are still funds remaining from FY23.
  - Denise states that the board should stick to the master plan as it identifies items the public has already commented on and to possibly address a public safety plan.
  - Wyeth suggested asking for more detailed information such as what areas need attention and how big of an area we'd be looking at.

#### 6. June 2023 Consultant Report

- Jim received a phone call from a Jr. hockey league out of Atlanta that is excited about the rec center project. They stated that they have had their eye on our area for quite some time and if the rec center succeeds, they are on board to move into the area.
- Andrew asked what support the board can give to help push the rec center project along, if any.
